

## **Availability of Nursing Home Compliance Information**

This notice is intended to inform residents and their families of publicly available information regarding nursing home quality and compliance maintained by the **New York State Department of Health (NYSDOH)** and the **Centers for Medicare & Medicaid Services (CMS)**.

Both NYSDOH and CMS maintain information on nursing homes, including quality measures, complaint history, inspection findings, citations, enforcement actions, and any applicable penalties. These resources are available to help residents and families make informed decisions regarding long-term care providers.

CMS provides the **Care Compare** tool, which allows consumers to review nursing homes and other healthcare providers nationwide. NYSDOH also maintains the **Nursing Home Profiles** website, which offers facility-specific information for nursing homes across New York State.

CMS recommends using this information together with discussions with your physician, social worker, or other healthcare professionals when evaluating nursing home options.
